IN 2019/2020, WE PROVIDED 297 INDIVIDUALS WITH 14,157 NIGHTS OF LODGING AND 42,471 MEALS. FROM THOSE WHO EXITED OUR SHELTER, 71% SUCCESSFULLY TRANSITIONED INTO POSITIVE HOUSING.
