INCREASING PARENT AND FAMILY INVOLVEMENT IS A HUGE GOAL OF THE BGCK'S OUTREACH EFFORTS. THE CLUB BEGAN A DROPOUT PREVENTION PROGRAM, "BE GREAT GRADUATE", AT THE START OF THE 2019-2020 SCHOOL YEAR.
