 The largest program at Tapestry Folkdance Center (Tapestry) is weekly dances. Tapestry hosts weekly dances in a variety of styles, including Contra, International, English Country, Waltz, and Ballroom. In this fiscal year, Tapestry hosted over 200 dances, before suspending weekly dances in March due to the pandemic. On a typical weekend, 100 - 200 people participated in weekly dances. Tapestry also hosted monthly dances including a family dance and a dance for seniors. Most dances include instruction.

 In addition to the weekly and monthly dances, Tapestry hosted three large weekend events that drew dancers from around the region and the nation, and several smaller events.

 Tapestry owns the building at 3748 Minnehaha Avenue in Minneapolis and makes it available for non-affiliated dance groups. During the year, roughly two dozen dance organizations rent studio space to teach a wide variety of dance forms.
