Bold ReThink/ Women's Congress Program: Bold ReThink is a new program started in 2019. The mission of this project is two-fold: 1) to expose, discredit, and dismantle the radical right-wing corporate agenda that has undermined people's faith in democracy and the power of government to be a force for good; and 2) to work with progressive Americans to rebuild trust in government through a progressive democracy that assures the health and well-being of people and our planet. We advocate for bold solutions that will help address the big challenges we face in 21st century America. The Womens Congress work continues with consultations, group online meetings and a Democracy Summit with speakers and musicians on how to group together to make changes.

Grass Roots Program/ Legal Program: The Science & Environmental Health Network provided legal and scientific expertise to grassroots campaigns working to protect water, climate and public health. We shared our 25+year expertise in law, science and innovative policy through intensive local workshops, factsheets, workbooks, guidance and technical assistance. Consulted with regulators and media about permits and monitoring with pipelines around the country. Incorporated the legal principles of the Commons, Free, Prior and Informed Consent, The Public Trust and the Precautionary Principle in environmental work around the country. Worked with coalitions in Iowa recommending to state officials about shifting the states budget from enriching corporations to caring for the commonwealth and public health.

Ecological Medicine Program: Science & Environmental Health Network worked extensively with many community groups and non-governmental organizations in the US, addressing many aspects of human health and the environment through an Ecological Model of Health. We provided scientific expertise to community groups and individuals who were tackling problems of pesticides, toxic chemicals in consumer products, contaminated drinking water and air. Conducted analysis, wrote white papers, and gave numerous presentations on the food-agriculture-climate connection as a strategic point for climate change mitigation and adaptation. Regularly provided content to numerous listservs of the Collaborative on Health and the Environment. Served as science advisor and speaker for the Health Care Without Harm Safer Materials and Healthy Food in Health Care workgroups.
