The Lift Garage provided low-cost car repairs for people making 30% of the Area Median Income and below. During the current year, The Life Garage repaired 706 cars saving their customers \$425,600 in car repair costs as compared to purchasing those repairs at current market rates. In addition, free inspections were completed on 218 cars with advice not to spend money to repair the vehicle as the repair outweighed the value of the vehicle saving \$87,500 in repair costs. Pre-purchase inspections were performed on 44 cars saving \$2,000 in inspection costs per car and much more in future costs. Estimate only appointments were performed for 61 cars saving \$2,000 in inspection costs per car. Car classes were conducted for 33 attendees.
