In 2020, Undies for Everyone distributed over 500,000 pairs of underwear to 100,000 students in Houston, Dallas, Austin, San Antonio, and Fort Worth. Undies for Everyone partnered with school district homeless departments, CPS organizations, food banks, and childrens hospital mobile clinics to serve the students most in need in our communities. All Undies recipients live below the poverty line and are between the ages of 3 and 14. Over 60 of recipients are Hispanic, 25 are African American, and White, Asian, and Pacific Islander make up the remainder of the ethnic breakdown.
