RESEARCH, CLINICAL CARE AND PHYSICIAN EDUCATION:THE AUTOIMMUNE ENCEPHALITIS ALLIANCE (AE ALLIANCE) CLINICIANS NETWORK CONTINUES TO BE A PREMIER SOURCE WORLDWIDE FOR PATIENTS AND CAREGIVERS SEEKING PHYSICIANS WHO HAVE EXPERIENCE TREATING AE. WE HAVE ADDED 34 DOCTORS FROM AROUND THE GLOBE TO THIS NETWORK IN 2020, AN INCREASE OF 22%, WITH A TOTAL OF 189 CLINICIANS PARTICIPATING BY 2020 YEAR-END. THE PHYSICIANS IN OUR CLINICIANS NETWORK INCLUDE SOME OF THE MOST RENOWNED EXPERTS IN THE FIELD OF AUTOIMMUNE ENCEPHALITIS, AND FREQUENTLY PARTICIPATE IN RESEARCH, CONDUCT CLINICAL TRIAL STUDIES, AND SPEAK IN NATIONAL FORUMS ABOUT THIS RARE DISEASE.DURING THE 2020 FISCAL YEAR THE AE ALLIANCE SUPPORTED 4 SIGNIFICANT RESEARCH STUDIES, PROVIDING RESOURCES ENABLING THE STUDIES TO BE COMPLETED AND/OR PUBLISHED TO THE AE PHYSICIAN AND PATIENT COMMUNITIES.THE AE ALLIANCE MEDICAL ADVISORY BOARD (MAB) ORGANIZED AROUND THREE KEY TOPIC AREAS DURING THE 2020 YEAR - EDUCATION, RESEARCH, AND CENTERS OF EXCELLENCE. THE MAB INCLUDES 17 EXPERTS ON AUTOIMMUNE ENCEPHALITIS (AE) FROM A VARIETY OF KEY DISCIPLINES - NEUROLOGY, RHEUMATOLOGY, AND PSYCHIATRY. EACH GROUP MET OVER THE COURSE OF THE YEAR TO WORK ON KEY CONCEPTS OR GOALS ASSOCIATED WITH NEW INITIATIVES FOR THE ALLIANCE (I.E. WEBSITE DEVELOPMENT AND NEW GRANT PROGRAM).DURING 2020, THE AE ALLIANCE LAUNCHED ITS FIRST SIGNIFICANT FUNDRAISING EFFORT FOR AE RESEARCH, THE RESEARCH NETWORK, RAISING SEED FUNDING TO LAUNCH A NEW RESEARCH GRANT INITIATIVE IN DECEMBER, THE AE COMMUNITY SEED GRANT PROGRAM. FIRST AWARDS WILL BE GIVEN IN THE SUBSEQUENT 2021 YEAR.

PATIENT SUPPORT:AE ALLIANCE WAS ONE OF FIVE NON-PROFIT ORGANIZATIONS CO-HOSTING THE INAUGURAL WORLD ENCEPHALITIS DAY ALLIANCE HELD FEBRUARY 20-23, 2020 IN DALLAS, TEXAS. THE CONFERENCE WAS HELD FOR ENCEPHALITIS SURVIVORS AND CARETAKERS OF WHOM 65 WERE IN ATTENDANCE (EXCLUDING SPEAKERS AND SPONSORS). THE CONFERENCE INCLUDED PRESENTATIONS FROM EXPERTS IN THE FIELDS OF NEUROLOGY, PSYCHIATRY, NEUROIMMUNOLOGY, AND AUXILIARY SUPPORT DISCIPLINES. IN MARCH AE ALLIANCE HOSTED THE AE FAMILY WEEKEND FOR AE PATIENTS TO LEARN FROM AE EXPERTS AND SHARE EXPERIENCES DURING THE FLORENCE FORTH ROAD RACE WEEKEND. SEVERAL KEY PHYSICIANS GAVE UPDATES ON KEY TOPICS RELATIVE TO THE AE COMMUNITY. TWO INAUGURAL AWARDS WERE GIVEN BY THE PROGRAM SPONSOR, EUROIMMUN, - A PHYSICIAN AWARD AND A PATIENT ADVOCACY AWARD. TOTAL ATTENDING THIS PROGRAM INCLUDING SPEAKERS - 88.DURING THE 2020 FISCAL YEAR THE AE ALLIANCE EXPANDED AND LAUNCHED ITS PATIENT CARE EFFORTS WITH THREE REGIONAL SUPPORT GROUPS - A NORTHEAST GROUP BASED OUT OF NY, A MIDWEST GROUP BASED IN OH, AND A SOUTHERN GROUP BASED IN TX. THESE SUPPORT GROUPS GIVE PATIENTS AND CAREGIVERS WITHIN THE BROAD GEOGRAPHICAL REGION THE OPPORTUNITY TO LEARN FROM ONE ANOTHER, SHARE EXPERIENCES, AND HEAR FROM GUEST EXPERTS. A FOURTH SUPPORT GROUP WAS UNDER DISCUSSION AS THE 2020 YEAR END CLOSED - A WESTERN SUPPORT GROUP BASED IN CA. TOTAL PARTICIPANTS REGISTERED FOR SUPPORT GROUPS AS OF YEAR-END - 93.MULTIPLE MONTHLY INQUIRIES FROM PATIENTS AND CAREGIVERS VIA EMAIL WERE ANSWERED, PROVIDING PATIENTS WITH TOOLS TO CONTINUE TO BATTLE THIS DISEASE. PEER-TO-PEER CONNECTIONS WERE MADE THROUGHOUT THE YEAR AND OUR ONLINE SMART PATIENTS AE COMMUNITY GREW TO 629 MEMBERS, AN INCREASE OF 20%, EXCHANGING EXPERIENCES, KNOWLEDGE AND INFORMATION.

AE DISEASE AWARENESS AND ADVOCACY:WE ISSUED OUR FIRST SEMI-ANNUAL NEWSLETTER IN DECEMBER OF 2019 AND FOLLOWED IT WITH A TWO ADDITIONAL NEWSLETTERS IN 2020. OUR NEWSLETTERS WERE DISTRIBUTED TO 2,261 PATIENTS, CAREGIVERS, AND PHYSICIANS AND ARE AVAILABLE ON-LINE THROUGH OUR WEBSITE. OUR E-NEWSLETTER, CONTAINING SUMMARIES OF RECENT MEDICAL JOURNAL PUBLICATIONS AND BLOGS WERE SENT MONTHLY TO OUR MAILING LIST OF OVER 2,200 PATIENTS, CAREGIVERS AND PHYSICIANS. OUR FACEBOOK PAGE IS FOLLOWED BY 6,304 PEOPLE, KEEPING UP-TO-DATE WITH OUR LATEST BLOGS AND RESOURCES.EACH YEAR SINCE ITS INCEPTION IN 2012, THE AE ALLIANCE HAS HELD THE FLORENCE FORTH ROAD RACE IN DURHAM, NC NOT ONLY TO RAISE FUNDS FOR SUPPORT SERVICES TO THE AE COMMUNITY, BUT TO EXPAND AWARENESS OF THE DISEASE. IN 2020 A TOTAL OF 1,040 PEOPLE REGISTERED FOR THIS ANNUAL RACE IN HONOR OF SIX YEAR-OLD FLORENCE MCDOW WHO LOST HER BATTLE TO AE IN 2012. IN JULY AND AUGUST OF 2020, THE AE ALLIANCE PARTNERED WITH EVERYLIFE FOUNDATION'S ADVOCACY COALITION, RDLA, TO BRING RARE DISEASE ISSUES TO THE FOREFRONT WITH OUR STATE LEGISLATORS IN NC AND FL KEY PATIENT ADVOCATES AND NON-PROFIT SUPPORT GROUPS LIKE THE AE ALLIANCE MET WITH LEGISLATORS VIRTUALLY TO ADVOCATE FOR KEY ISSUES IMPACTING THE RARE DISEASE COMMUNITY. THE AE ALLIANCE SOUGHT TO EDUCATE THE LEGISLATORS ON THE RARE DISEASE OF AUTOIMMUNE ENCEPHALITIS AND ASK THEM TO JOIN THE RARE DISEASE CONGRESSIONAL CAUCUS.IN OCTOBER OF 2020 THE AE ALLIANCE LAUNCHED A NEW ADVOCACY PROGRAM, AE ON THE HILL, TO ENABLE PATIENTS AND CAREGIVERS TO ADVOCATE FOR THEMSELVES OR THOSE SUFFERING FROM AE. IN PARTNERSHIP WITH GLOBAL GENES, THE ALLIANCE HELD AN INAUGURAL CLASS FOR PATIENTS AND CAREGIVERS ON HOW TO TELL THEIR STORY. THE PROGRAM IS ENVISIONED TO GROW OVER THE NEXT FIVE YEARS WITH TRAINING SESSIONS EACH OCTOBER. A TOTAL OF 23 PATIENTS AND CAREGIVERS PARTICIPATED IN THE INAUGURAL TRAINING PROGRAM.
