ALL OBJECTIVES WERE MET IN 2020: RESTORED DEGRADED HABITATS THROUGH THE ST. CHARLES BAY OYSTER REEF RESTORATION, CREATED NEW HABITATS THROUGH THE BRAD VINCENT REEF EXPANSION, ADVANCED THE SCIENCE OF HABITAT RESTORATION AND CONSERVATION WITH THE HARTE RESEARCH INSTITUTE NEARSHORE REEFING STUDY, FOSTERED HABITAT STEWARDSHIP THROUGH THE LOUISIANA TAG PROGRAM, AND EDUCATED COASTAL COMMUNITIES OF THE VALUE OF CONSERVATION WITH THE RISING TIDE YOUTH INITIATIVE.

BCT FUNDED \$400,000 TO THE RIO GRANDE VALLEY NEARSHORE REEF. THIS NEARSHORE REEFING PROJECT IS ONE OF THE MOST COMPLEX OF ITS KIND ALONG THE GULF COAST. THROUGH THE PARTNERSHIP WITH FRIENDS OF RIO GRANDE VALLEY REEF, THE PROJECT HAS CREATED A FULL "LIFE-CYCLE" REEF THAT PROVIDES CRITICAL HABITAT FOR ALL LIFE STAGES FOR MARINE SPECIES FROM LARVAL AND FINGERLINGS, TO FULLY MATURE SPECIES. IN ADDITION TO THIS PHASE OF THE PROJECT WHICH PROVIDED MORE LOW RELIEF MATERIALS IN THE REEF SITE, THE REEF SITE HAS VESSELS, LARGE MOUNDS OF RECYCLE CONCRETE RAILROAD TIES, CONCRETE RUBBLE, LARGE STEEL SPOOLS AND MUCH MORE THAT PROVIDE EXCELLENT FISHING GROUNDS FOR LOCAL AND VISITING RECREATIONAL FISHERMEN.

BCT FUNDED \$329,000 TO THE BIG MAN'S / KATE'S REEF SITES LOCATED IN THE NEARSHORE WATERS JUST SOUTH OF GALVESTON, TEXAS. THIS PROJECT IS A PARTNERSHIP BETWEEN TEXAS PARKS AND WILDLIFE DEPARTMENT (TPWD) AND PRIVATE DONORS THAT PROVIDES NEARSHORE HABITAT FOR MARINE SPECIES IN THE UPPER TEXAS COAST. TPWD IS LEADING THIS PROJECT THAT WILL USE VARIOUS TYPES OF MAN-MADE REEFING MATERIALS IN DIFFERENT CONFIGURATIONS TO PROVIDE HABITAT FOR MARINE SPECIES IN DIFFERENT LIFE CYCLES IN AN AREA THAT ONCE HELD ARTIFICIAL REEFS IN THE FORM OF OIL AND GAS PLATFORMS. THE PROJECT WILL PROVIDE EASILY ACCESSIBLE ACCESS TO LOCAL AND VISITING ANGLERS TO THE GALVESTON AND FREEPORT AREAS.
