THROUGH IMPACT LITIGATION, POLICY REFORM, AND PUBLIC OUTREACH WE SEEK RADICAL REFORM OF SYSTEMIC INEQUALITIES IN OUR JUSTICE SYSTEM. WE BELIEVE THE JUSTICE SYSTEM SHOULD IMPROVE WELL-BEING ACROSS SOCIETY, BUT REPEATEDLY IT CREATES CYCLES OF POVERTY, RUINS LIVES, AND MAKES EVERYBODY LESS SAFE. WE TOOK A STEP TOWARD HELPING OVER 100,000 INDIGENT RESIDENTS OF LOUISIANA EXPUNGE OLD CRIMINAL RECORDS. WE ALSO MADE PROGRESS IN PREVENTING HUNDREDS OF THOUSANDS OF RESIDENTS OF SAN FRANCISCO FROM BEING KEPT IN JAILED SOLELY BECAUSE THEY ARE TOO POOR TO AFFORD MONEY BAIL. WE CONTINUED OUR EFFORTS TO HELP THOUSANDS OF INDIGENT RESIDENTS OF MISSOURI REGAIN THEIR DRIVING PRIVILEGES.
