THE PROGRAM'S PURPOSE WAS TO STABILIZE APPALACHIAN CDFIS AND REVOLVING LOAN FUNDS SERVING SMALL BUSINESSES IMPACTED BY COVID-19. 31 LENDERS RECEIVED GRANTS TO COVER OPERATIONAL COSTS AND OFFSET INCOME THEY LOST BY SUSPENDING OR REDUCING PAYMENTS DURING THE PANDEMIC. NOT ONLY DID ACC MEET THE THREE-WEEK DEADLINE, BUT THE PROGRAM WON PRAISE FROM ARC CO-CHAIRS TIM THOMAS AND OHIO GOVERNOR MIKE DEWINE. GRANT RECIPIENTS RECEIVED A TOTAL OF \$3.56 MILLION IN GRANTS.
