We hope that this partnership will produce fruit for our ministry and for the many others who are our partners.2)We were able to spend approximately \$72,527 in direct distributed funds for food and medical relief in Africa during the COVID-19 pandemic.3)We finished the writing and editing of our first 25 Study Courses in Theology, Education, and selected topics for our accredited programs.4)We formalized our accreditation by the National Council for Higher Education in Uganda for a provisional license to grant 2 year Diploma (and Certificate) Degrees through our school Trinity Biblical Institute in Kapchorwa, Uganda.5)We continued our radio ministry through WKTR Trinity Kapchorwa Radio.6)We continued our medical ministry (including patient evangelism with our clinic evangelist) through the Kaserem Christian Medical Clinic.7)The TBI Website (Uganda) has been put up at www.trinitybi.ac.ug This website also links you to the TBI social media platforms on facebook and twitter as well.8)The TCWM LTD Board began to be organized and refined in its principles and practices on the ground, and TBI Central Management Team made key full-time hires for the seminary and established its working plan to offer the accredited classes beginning first of the year in 2021.9)The TCWM President and Vice President were able to spread the message about the work of TBI at many churches through speaking engagements and personal meetings.10)We were able to stockpile our medical clinic through a significant grant with specific equipment and supplies related to helping with the COVID-19 pandemic.11)We planned and received permits for our campus building master plan and projects in Kapchorwa, Uganda.12)Our TCWM USA Presidential search-process was successfully organized and initiated.
