Further, it believes that, if it were not for COVID, its fundraising efforts would have continued to be at or above the 1/3rd amount. For all these reasons, the organization believes it satisfies the facts and circumstances test set forth in Treas. Reg. 1.170A-9(f)(3) and therefore qualifies as publicly supported.</p>
