Our plan is to research alternative programming options (virtual, digital) to continue our mission until it has been deemed safe to return to in-person programming. We will continue our fundraising efforts to support professional musicians during the COVID-19 pandemic and seek sustaining funds to keep the organization running and ready for business when the pandemic is no longer a considered a public threat.
