NOORA HEALTH DEVELOPS SYSTEMS TO TRAIN AT-RISK PATIENTS AND THEIR FAMILIES WITH HIGH-IMPACT HEALTH SKILLS TO IMPROVE OUTCOMES AND SAVE LIVES. IN 2020, THE NOORA HEALTH PROGRAM REACHED 461,337 FAMILY MEMBERS REPRESENTING AN ESTIMATE OF 283,813 PATIENTS. THIS BRINGS THE TOTAL NUMBER OF FAMILY MEMBERS TRAINED AS OF DECEMBER 31, 2020, TO 1,054,903. IN 2020, 1,349 NEW TRAINERS WERE EQUIPPED TO DELIVER TRAINING TO FAMILIES AND 6 HOSPITAL PARTNERSHIPS WERE ADDED. THE PROGRAM IS NOW LIVE OR UNDERGOING IMPLEMENTATION IN OVER 165 FACILITIES WITH CONTENT AVAILABLE FOR POST-SURGICAL, CARDIAC, ONCOLOGY, AND NEONATAL/ANTENATAL CARE.
