Our Food Rescue Program rescues an average of 14,000+ pounds of high-quality, largely perishable, surplus fresh food every day from local grocers, retailers, farmers markets, restaurants, and wholesalers. It is then sorted and delivered by our team of volunteers and staff in refrigerated vehicles the same day to dozens of organizations serving those in need. The White Pony General Store Program (WPGS) distributes new and like-new clothing, shoes, toys, childrens books, and games to our Contra Costa neighbors in need.
