And we helped 452 households complete the census. 2) Virtual Programming:We launched a full set of virtual programming that kept our community educated and entertained during the height of the pandemic. In addition, we grew our following to a national level where we had people tuning in from all over the country to benefit from our virtual series including Palestine Mondays, Workshop Wednesdays and Community Check-in Fridays. This was not only a temporary fix, but has completely opened a new opportunity for us where we will continue to offer our services online for our newfound community across the country to keep benefitting from. 3) COVID-19 ReliefWe were able to provide sanitary packages of gloves, masks and sanitizer to over 1,000 families, 9 police and fire departments, 3 hospitals and 5 senior citizen homes. We gave boxes of food essentials to over 1,000 families, and hot meals for 500 individuals Monday through Friday for over a month.
