 The purpose of Wikitongues is to safeguard linguistic diversity by supporting grassroots linguistic documentation efforts, including the creation of video oral histories, audio recordings, and dictionaries, archiving and publishing language documentation, and supporting community-led language revitalization initiatives.

**28** Language documentation: in 2020, Wikitongues volunteers created 269 video oral histories in 152 unique languages, of which 25 are at-risk or critically endangered, and one dictionary in the Kihunde language of D.R. Congo. The organization published many of these videos to an online audience of nearly 100,000 subscribers. Collectively, Wikitongues language videos received at least 7.9 million unique views in 2020.

**29** Language archiving: in 2020, Wikitongues standardized its archival infrastructure by developing a long-term preservation protocol with MLS students from Queens College in New York City and the advice of archivists from the U.S. Library of Congress. The organization also established a formal relationship with the U.S. Library of Congress, which will back up appropriately licensed language documentation on an ongoing basis. Finally, the organization launched a public-facing archive at Wikitongues.org, in order to make its collection of linguistic documentation more accessible.
