Consumer AwarenessHeld third Get Hooked Restaurant Week with 18 participating restaurants. Developed online Local Catch guide that includes the restaurants, community-supported fisheries, markets, and fishermen that sell locally harvested seafood, with more than 14,000 views in 2020. Launched the #MontereyBaySeafood campaign to build excitement around king salmon and other seasonal fish. Through digital storytelling, videos, blogs, email newsletters, social media, and the press, more than 320 thousand consumers learned (many for the first time) about seafood seasonality and sustainability, while getting to know their neighbors in the fishing community.

Industry Engagement and SupportParticipated on the West Coast Marine Resource Education Programs steering committee and provided scholarships for four fishermen to attend the workshops. Hosted two in-person and five virtual meetings with 27 stakeholders regarding fisheries conservation and management, developed and shared web resources with 412 industry newsletter subscribers, and provided technical assistance via webinars and direct support to 133 fisheries stakeholders regarding COVID relief and the Seafood Trade Relief Program. Supported fishermen as they transitioned to direct-to-consumer markets, creating a fishermen's Guide to Dock Sales and an online How to Buy off the Boat guide for consumers and helped market weekend dock sales. Partnered with California FarmLink to develop a lending tool for fishermen, setting the stage for a longer-term fishermen's technical assistance and loan program.
