OUR TEAM REGISTERED 6,179 ELIGIBLE US CITIZENS TO VOTE AND MADE A TOTAL OF 77,766 CALLS, 3,197 TEXTS, AND DISTRIBUTED EDUCATIONAL MATERIALS AT 20,664 DOORS. IN ADDITION, WE WERE ABLE TO STAGE 7 DIFFERENT NON-PARTISAN VOTER PROTECTION EVENTS WITH VOLUNTEERS AND ENGAGED WITH MORE THAN 600 VOTERS. WE PUBLISHED MORE THAN A DOZEN ENGLISH & IN-LANGUAGE PSAS ON VOTER EDUCATION AND VOTER PROTECTION TO INCREASE VISIBILITY OF KEY RACES TO ASIAN AND YOUTH VOTERS.
