WE PROVIDE HOLISTIC, TRAUMA-INFORMED SERVICES, ENGAGING PARTNER ORGANIZATIONS AND HUNDREDS OF VOLUNTEERS TO CONNECT OUR CLIENTS WITH FREE MEDICAL, MENTAL HEALTH, AND SOCIAL SERVICES. OUR MODEL FOCUSES ON EMPOWERING MIGRANTS TO ORGANIZE AND LEAD OUR EFFORTS.

AL OTRO LADO IS A PARTNER ORGANIZATION AT THE WELLNESS CENTER LOS ANGELES, LOCATED IN THE HISTORIC LA COUNTY GENERAL HOSPITAL BUILDING ON THE LAC+USC HOSPITAL CAMPUS. HOUSED WHERE MANY OF OUR CLIENTS AND THEIR FAMILIES ARE RECEIVING CARE, WE OFFER FREE IMMIGRATION LEGAL SERVICES TO LOW-INCOME INDIVIDUALS.
