AIM FUNDED RESEARCH HAS THE POTENTIAL TO REACH EVERY CHILD IN THE US WHO HAS ACCESS TO TREATMENT. TO REACH THOSE WITH ACCESS AS WELL AS THOSE WITHOUT ACCESS TO TREATMENT, AIM ESTABLISHED THE AIM BEYOND COVID FUND TO TAKE TREATMENTS VIRTUAL, THEREBY REACHING LARGER POPULATIONS THROUGH TELE-HEALTH AND DIGITAL MEDICINE. IN 2020 AIM'S RESEARCH PROGRAMS INCLUDE FUNDING AN AIM CLINICAL SCIENCE FELLOW AT THE UNIVERSITY OF VIRGINIA WHO WILL DEVELOP AND EVALUATE A FREE, EASY-TO-ACCESS TECHNOLOGY-DELIVERED INTERVENTION (TDI) FOR YOUTH ANXIETY USED WITHIN THE CONTEXT OF FORMAL MENTORING PROGRAMS; TWO COORDINATED TELEHEALTH FAMILY INTERVENTION EATING DISORDER STUDIES AT THE UNIVERSITY OF SAN DIEGO AND STANFORD, FOCUSED ON FEASIBILITY, ACCEPTABILITY AND PRELIMINARY CLINICAL UTILITY OF TELEHEALTH TO DELIVER FAMILY INTERVENTIONS FOR EATING DISORDERS IN YOUTH.
