CIVIC HALL @ UNION SQUARE - SLATED TO OPEN IN LATE 2021, WITH IN-DEPTH PLANNING STARTED IN LATE 2017, CIVIC HALL @ UNION SQUARE WILL BE A NEW, DIVERSE, AND INCLUSIVE 21ST CENTURY COMMUNITY CENTER FOCUSED ON TECHNOLOGY, CIVIC ENGAGEMENT, AND A MORE EQUITABLE FUTURE FOR ALL. IT WILL BE HOUSED ON SIX FLOORS AND INCLUDE A 40,000 SQUARE FOOT COLLABORATIVE COMMUNITY SPACE, WITH A STATE-OF-THE-ART 400-SEAT CONFERENCE AND EVENTS CENTER.
