BEACH STRUCTURE: RESTORATION AND RESILIENCE - DBR STRIVES TO PROACTIVELY STRENGTHEN AND PRESERVE THE BARRIER BEACH THROUGH ANNUAL MAINTENANCE INCLUDING DUNE RENOURISHMENT AND REPAIR, COBBLE BERM RESTORATION, FERTILIZATION, PLANTING BEACH GRASS AND WOODY VEGETATION AND INSTALLING FENCING. LARGE-SCALE RESILIENCE PROJECTS THAT REQUIRE LARGE-SCALE ANALYSIS, PLANNING AND CONSTRUCTION WORK SERVE TO STRENGTHEN THE BARRIER BEACH. DBR MUST ALSO RESPOND TO STORM ALTERATIONS SUCH AS EROSION AND FLOODING IMPACTS AS NEEDED.

COASTAL ECOLOGY PROGRAM: THE COASTAL ECOLOGY PROGRAM INCLUDES VEGETATION MANAGEMENT, SPECIES INVENTORYING, AND MAINTENANCE OF MULTIPLE HABITAT TYPES - FROM ROCKY INTERTIDAL TO DUNES TO SALTMARSH. ONE ASPECT OF THE COASTAL ECOLOGY PROGRAM IS TO PROTECT THE STATE AND FEDERALLY LISTED SPECIES ON DUXBURY BEACH WHICH INCLUDES TWO NESTING BIRD SPECIES. DBR HAS AN EXTENSIVE AND COMPLEX MANAGEMENT, MONITORING, AND REPORTING PROGRAM IN ORDER TO PROTECT NESTING BIRDS WHILE ALLOWING RECREATIONAL ACCESS.

BEACH OPERATIONS AND ACCESS (FORMERLY KNOWN AS RECREATION AND BEACH ACCESS): DBR STRIVES TO MAINTAIN RECREATIONAL ACCESS TO THE BEACH WHEN POSSIBLE. YEARLY ROAD GRADING AND REPAVING ALONG WITH CROSSOVER REPAIRS AND FENCING ALONG THE ROADWAY ALLOW FOR SAFE RECREATION. THE RESERVATION LEASES A LARGE PORTION OF THE BEACH TO THE TOWN OF DUXBURY. BEACH STICKERS CAN BE PURCHASED FROM THE TOWN FOR ACCESS TO THE PARKING LOTS AND THE OUTER BEACH FOR OVERSAND VEHICLES. THE DUXBURY BEACH OPERATIONS DIVISION MANAGES THE PEOPLE AND VEHICLES ON THE BEACH. MOBILITY MATS ARE INSTALLED ON PATHS LEADING FROM THE PARKING LOT TO THE BEACH TO ALLOW MORE ACCESSIBILITY FOR THOSE WHO LIVE WITH CONDITIONS THAT LIMIT THEIR MOBILITY.

DUXBURY BEACH PARK: DUXBURY BEACH PARK IS LOCATED AT THE NORTHERN END OF THE BEACH AND PROVIDES ACCESS FOR DAY VISITORS. DBR HIRES A MANAGER TO OPERATE THE PARKING LOT AND FOOD PAVILION AND RECEIVES A PORTION OF THE PARKING REVENUE. DBR MAINTAINS THE PARKING LOTS, BUILDING, AND BEACH AT THE PARK ANNUALLY AND AS LARGER NEEDS ARISE.

COMMUNITY OUTREACH AND EDUCATION: DBR WORKS YEAR ROUND TO COMMUNICATE WITH VISITORS, LOCAL COMMUNITIES, AND OTHER STAKEHOLDERS ABOUT THE IMPORTANCE OF DUXBURY BEACH AND THE NEED TO PRESERVE AND MAINTAIN IT. THIS IS ACCOMPLISHED THROUGH ELECTRONIC COMMUNICATION, SIGNAGE ON THE BEACH, EDUCATIONAL PROGRAMS, AND VOLUNTEER DAYS. THE DUXBURY BEACH VOLUNTEER COMMUNITY HAS TAKEN ON EVERYTHING FROM TESTING NEW EROSION CONTROL METHODS, TO ORGANIZING PLANTING AND CLEANUP EFFORTS, TO PROTECTING AND IMPROVING THE BEACH THROUGH SIGNAGE, OUTREACH AND A MULTITUDE OF OTHER PROJECTS.
