SINCE THEN, THE PDI HAS EXPANDED ITS SERVICES AND OPENED TWO ADDITIONAL CLINICS IN THE CITIES OF NABLUS AND HEBRON, COVERING A WIDER POPULATION IN THE WEST BANK. IT NOW EMPLOYS MORE THAN 20 PALESTINIANS, INCLUDING ENDOCRINOLOGISTS, LAB TECHNICIANS, NURSES, ASSISTANTS, AND OTHERS. THE PDI ADDRESSES THE GROWING DIABETES EPIDEMIC IN PALESTINE THROUGH COMPREHENSIVE TREATMENT AND EDUCATION, AND IS THE FIRST SUCH FACILITY IN PALESTINE.
