Environmental Education: Despite the COVID-19 pandemic, AWS succeeded in working with more than 2,600 local watershed residents to take direct action in our environmental education, stewardship, advocacy, and recreation programs. Due to school closures that went into effect with the pandemic, AWS was unable to engage students in our regular three-part education programs; however, we were able to quickly adapt our programming to provide distance- learning alternatives. AWS facilitated virtual class visits, which were conducted as live presentations with largely the same content as students would have in person, with necessary tweaks in delivery, and customized to the needs of the teacher. Our team of educators created activities and lessons that students could complete at home with no special equipment and within the safety of their own home, yard, or nearby greenspace. We also developed and released a series of videos. Through these adaptations, AWS was able to educate and engage more than 1,500 students. Additionally, we provided professional development and mentoring to more than 137 teachers from DC and Maryland schools. AWS was also able to engage 36 students in our Saturday Environmental Academy, a program designed to engage middle school students through 7 weeks of leadership and environmental skills learning. Students engaged in hands-on, in-person outdoor activities, including serving as citizen scientists at a vernal pool, investigating mussels and other aquatic life at Kenilworth Aquatic Gardens, planting trees in the watershed, and more.

4b (Code:) (Expenses \$ 697,295 including grants of \$ 0) (Revenue \$ 427,638)

Stewardship: AWS reduced pollution entering the river by installing rain gardens and green infrastructure practices in the watershed that will capture and treat approximately 228,000 gallons of stormwater runoff on an annual basis. Despite the pandemic, our staff and volunteers were able to plant 460 trees, more than 15,000 square feet of wetlands, and 2,000 square feet of meadows. We continued to operate trash traps on tributaries of the river to collect data on litter trends and prevent trash from entering the river. In the fall, AWS safely hosted a belated version of our annual Earth Day Cleanup, which engaged approximately 500 volunteers spread out at dozens of sites throughout the watershed to remove more than 17 tons of trash and 57 tires from the river and adjacent parkland. We also propagated and released more than 12,000 mussels into the river. On an annual basis, these mussels will filter more than 43 million gallons of water, the equivalent of 66 Olympic-size swimming pools!

4c (Code:) (Expenses \$ 258,222 including grants of \$ 0) (Revenue \$ 1,500)

Advocacy: AWS continued to influence policies and resources favorably towards the restoration of the Anacostia River, with a particular emphasis on enhanced stormwater controls, reduction of trash inputs, and increased attention to remediation of legacy toxic chemicals impacting the river. We released our annual State of the River Report Card with a passing grade and several positive trends. The river earned its highest grade yet thanks to a complete resurgence of underwater grasses and actions taken by local jurisdictions to reduce trash and toxic sediment in the river. Working closely with the Choose Clean Water Coalition, AWS continued to represent the urban rivers in the Chesapeake Bay, promoted strong appropriations, and defended the Clean Water Act. We participated in the Choose Clean Water Lobby Day promoting the Coalition's legislative agenda. In September 2020, the District of Columbia released an interim Record of Decision that identifies a plan to greatly reduce the health risk posed by PCBs and other chemical contaminants in the river. In total, an area of approximately 77 acres will be cleaned up, reducing the human health risk by approximately 90%.
