CHILDREN WORK WITH STAFF SETTING DAILY AND WEEKLY BEHAVIOR MANAGEMENT GOALS WHILE FORGING FRIENDSHIPS AND HAVING SUMMER FUN. THE ORGANIZATION ALSO HAS A COUNSELOR IN TRAINING (C-I-T) PROGRAM FORMER CAMPERS GET 1:1 COACHING AND LEARN JOB SKILLS THAT PREPARE THEM FOR FUTURE EMPLOYMENT. INDIVIDUAL GOALS ARE SET THAT INCLUDE COMPUTER, OFFICE AND ORGANIZATION SKILLS CUSTOMIZED TO THEIR SITUATION.
