 Camp Opportunity Incorporated provides a week long sleep away summer camp for at-risk children from the Baltimore metropolitan area at no cost to the families. Each child receives his/her own counselor for the week. The activities and classes are designed to build self-esteem and foster relationships of trust.

**28** Each year, Camp Opportunity volunteers plan and implement a themed, week-long residential summer camp for approx. 40 abused/neglected children (ages 8-11) from Central Maryland. The camp is unique in that it pairs children 1 to 1 with their own trained counselor for the entire week. This provides care and attention that is oftentimes missing in these children's day to day lives. The week is infused with daily lessons that teach resilience, empowerment and life skills to help them navigate difficult situations in a more positive manner. Interim activities are held with counselors and campers. The organization conducts a graduation picnic in June of every year to celebrate campers who have completed their four years of camp and targeted year-round programming.
