THE NONPROFIT INITIATIVE IN PUERTO NATALES, CHILE WORKS TO CREATE A SUSTAINABLE FUTURE FOR THE ICONIC TORRES DEL PAINE NATIONAL PARK AND ITS SURROUNDING COMMUNITIES. THE LEGACY FUND PROMOTES A DESTINATION STEWARDSHIP MODEL THAT BRINGS TOGETHER PUBLIC AND PRIVATE STAKEHOLDERS TO COLLECTIVELY IMPLEMENT AND FINANCE SUSTAINABILITY ACTION PROJECTS. THE INFORMATION PRESENTED IN BOTH WORKSHOPS INSPIRED CREST TO COMPILE A COLLECTION OF ARTICLES AS A FOUNDATIONAL RESOURCE TO SHARE THE IDEAS THAT EMERGED IN THOSE SPACES, CONVERTING TECHNICAL INFORMATION AND ACADEMIC RESEARCH INTO AN EASILY-UNDERSTANDABLE PUBLICATION.
