THE ALLEGHENY COUNTY PARKS FOUNDATION HAS COMPLETED A VARIETY OF PROJECTS IN THE NINE COUNTY PARKS, IN PARTNERSHIP WITH THE ALLEGHENY COUNTY GOVERNMENT. THESE INCLUDE TRAIL IMPROVEMENTS TO THE NORTH PARK LAKE TRAIL; CONNECTOR TRAILS IN SOUTH PARK TO THE MONTOUR TRAIL AND IN SETTLERS CABIN TO THE PANHANDLE TRAIL; RENOVATIONS TO THE SOUTH PARK FAIRGROUNDS OVAL FIELDS AND TRACK; NEW DIRECTIONAL SIGNAGE AT DEER LAKES PARK TO SERVE AS A MODEL FOR FUTURE SIGNAGE IN OTHER PARKS; INTERPRETIVE SIGNAGE AT ROUND HILL, SOUTH AND NORTH PARKS; INSTALLATION OF 100 CHIMNEY SWIFT HABITAT TOWERS IN ALL NINE PARKS, PARTNERING WITH THE AUDUBON SOCIETY OF WESTERN PENNSYLVANIA; AND ECOLOGICAL RESTORATION ACTION PLANS FOR BOYCE, SOUTH, HARTWOOD ACRES AND SETTLERS CABIN PARKS. ECO-PLAN IMPLEMENTATION PROJECTS HAVE BEEN UNDERTAKEN, INCLUDING PLANTING MEADOWS AT BOYCE, SOUTH AND HARTWOOD ACRES PARKS AND MANY NEW LARGE TREES IN BOYCE AND SOUTH PARKS AND RIPARIAN PLANTINGS IN HARTWOOD, SOUTH AND NORTH PARKS. THE FOUNDATION HAS RESTORED THE SCULPTURE COLLECTION AT HARTWOOD ACRES AND IS PARTNERING WITH ALLEGHENY COUNTY ON A NEW SCULPTURE GARDEN SETTING FOR THE COLLECTION; CLEANING ABANDONED COAL MINE POLLUTION IN SETTLERS CABIN PARK; CONSTRUCTING A GREEN INFRASTRUCTURE PARKING LOT AT SOUTH PARK; AND RESTORING THE CASCADES AT SOUTH PARK. THE FOUNDATION IS ALSO WORKING ON TWO ADDITIONAL ECOLOGICAL RESTORATION ACTION PLANS FOR WHITE OAK AND ROUND HILL PARKS. FUNDRAISING HAS COMMENCED TO UNDERTAKE ECOLOGICAL ASSESSMENTS FOR THE HARRISON HILLS, DEER LAKES AND NORTH PARKS. THE FOUNDATION WILL BEGIN TO RESTORE THE STANDPIPE OBSERVATION TOWER IN NORTH PARK AND RESTORE THE NORTH PARK STORY POLE TO PRESERVE ITS RICH CULTURAL HISTORY.

THE PARKS FOUNDATION HAD ALREADY PLANNED TO LAUNCH A MARKETING CAMPAIGN TO INCREASE COMMUNITY AWARENESS OF THE PARKS AND THE PARKS FOUNDATION THROUGH PAID AND EARNED PRINT MEDIA AND SOCIAL MEDIA. THERE WAS ALSO A PLANNED CAMPAIGN TO ACQUIRE NEW DONORS. THE TIMING OF THE AWARENESS AND ACQUISITION CAMPAIGNS WAS PERFECTLY ALIGNED WITH INCREASED PARK USE AND WAS SUCCESSFUL WITH EXPANDING INDIVIDUAL DONATIONS AND NEW WEBSITE VISITORS. ALONG WITH GREATER PARK USE AND INCREASED AWARENESS, THE PARKS FOUNDATION EXPERIENCED A HIGHER LEVEL OF ENGAGEMENT WITH THE PUBLIC, AND THE DEMAND FOR PARK BENCH DONATIONS SKYROCKETED. WHILE ANNUAL IN-PERSON FUNDRAISING EVENTS WERE UNABLE TO TAKE PLACE, THE PARKS FOUNDATION MAINTAINED FINANCIAL SUPPORT FROM CORPORATE SPONSORS. IN ADDITION, PHILANTHROPIC GRANTS CONTINUED DURING 2020 WHICH HELPED TO MAINTAIN HARWOOD ACRES AND NORTH PARK PROJECTS. BECAUSE THE SCULPTURE GARDEN AT HARTWOOD ACRES, THE CASCADES AT SOUTH PARK, THE GREEN PARKING LOT AT SOUTH PARK WERE ALL IN DESIGN, ENGINEERING OR CONTRACTING PHASES, WORK WAS ABLE TO CONTINUE ON THESE PARKS PROJECTS. IN ADDITION, FIELD WORK IN THE PARKS FOR THE ECOLOGICAL ASSESSMENTS AND TREE/SHRUB PLANTING WAS ABLE TO BE DONE OBSERVING SOCIAL DISTANCING AND WEARING FACE COVERINGS. ADMINISTRATIVE AND FUNDRAISING TEAM MEMBERS OF THE PARKS FOUNDATION PROCEEDED WITH REMOTE DAY-TO-DAY OPERATIONS, EMPLOYING FREQUENT COMMUNICATION AND WEEKLY STAFF MEETINGS VIA ZOOM. BOTH THE TEAM AND BOARD CONTRIBUTED TO THE SUCCESS OF THE PARKS FOUNDATION IN 2020 BY REMAINING NIMBLE, ADAPTING TO UNCERTAINTY, AND SUPPORTING NEW METHODS OF FUNDRAISING.
