 Marriage and family program: This program consists primarily of the activities of CanaVox, a marriage movement founded by mothers to provide the intellectual tools to help people understand deep and complicated issues in contemporary debates about human sexuality. CanaVox facilitates reading groups that discuss these issues in 39 states and 31 countries. In 2020 CanaVox expanded its offerings for mothers and other adult women, and launched programs for girls and women in high school, college, and young adulthood. It is also developing programming geared toward fathers, boys, and young men. CanaVox's website is www.canavox.com.

 Other programs: The Witherspoon Institute occasionally provides advice, grants, or other support for organizations or scholars whose missions are very similar to its own. The Institute does not accept applications for such support. Such support develops out of preexisting relationships that the Institute may have with scholars through the Institute's own programming. In 2020 the Institute provided such advice and support for programs at Princeton University and other institutions.

The amount of our programming continues to increase along with rising student demand.
