FARMLAND HAS BEEN HIT HARDEST BY THIS CHANGE, WHICH REPRESENTS AN ECOLOGICAL, ECONOMIC, CULTURAL AND PUBLIC HEALTH CRISIS FOR SOUTH CAROLINIANS. THIS CHALLENGE WAS THE IMPETUS FOR THE CREATION OF GROWFOOD CAROLINA IN 2011.
