THIS INVOLVES WORKING WITH OUR 60 AFFILIATE ORGANIZATIONS (AT THE LOCAL, STATE, REGIONAL, AND NATIONAL LEVELS) AND OVER 136,000 INDIVIDUAL CITIZENS TO PROTECT NORTH CAROLINA'S AIR, WATER AND QUALITY OF LIFE. IN 2020, OUR GRASSROOTS BASE SENT MORE THAN 29,000 EMAILS TO DECISION-MAKERS ON ISSUES IMPACTING OUR STATE'S ENVIRONMENT AND PUBLIC HEALTH, MADE MORE THAN 300 PHONE CALLS, AND PARTICIPATED IN OVER 600 OFFLINE ACTIONS.
