THE CHILDREN'S EDUCATION, LARGELY FOR ELEMENTARY SCHOOLS IS DESIGNED IN CONJUNCTION WITH FLORIDA STATE STANDARDS AND ADMINISTERED BY VOLUNTEERS AND STAFF. THE ADULT PROGRAMS INVOLVES STAFF AND NON-STAFF EXPERTS CONDUCTING ACTIVITIES ON SITE AND ALSO INCLUDE VISITS TO OTHER LOCATIONS.

ENVIRONMENTAL EDUCATION OF CHILDREN: TRADITIONALLY TLNC HOST VISITS FROM ELEMENTARY PUBLIC, CHARTER AND PRIVATE SCHOOLS AS WELL AS HOME SCHOOLED CHILDREN PROGRAMS MEETING FLORIDA STATE EDUCATION STANDARDS. THESE ARE PRESENTED BY STAFF AND VOLUNTEERS. MOST FORMAL PROGRAMS AND ACTIVITIES WERE CURTAILED OR ELMINATED DUE TO COVID RESTRACTIONS. ACADEMNIC CONCEPTS SUCH AS ADAPTATION, HABITAT, FOOD WEBS, PHOTOSYNTHESIS AND MUCH MORE WERE PRESENTED VIA TOUCHLESS DISPLAYS AND OPPORTUNITIES FOR FAMILIES TO VISIT ON THEIR OWN DURING PERIODS OF TIME WHEN SCHOOLS WERE NOT OPEN AND OTHER EXTRACURRICULAR OPPORTUNITIES FOR EDUCATION WERE NOT AVAILABLE FOR MANY CHILDREN. THIS IS THEIR FIRST EXPERIENCE IN A NATURAL OUTDOOR CLASSROOM.

THE CENTER IS OPEN TO THE PUBLIC WITHOUT CHARGE. GROUPS CAN ARRANGE VISITS THAT INVOLVE STAFF AND/OR VOLUNTEERS. VISITORS CAN WALK THE TRAILS LEADING TO A BOARDWALK THAT ENDS AT A DOCK ON TROUT LAKE. THE EDUCATION AND MUSEUM BUILDINGS CONTAIN A LARGE COLLECTION OF MOUNTED SPECIMENS NATIVE TO FLORIDA, RANGING FROM VARIOUS BIRDS, SNAKES AND FISH TO A BLACK BEAR AND FLORIDA PANTHER. THERE ARE A SMALL NUMBER OF LIVE SPECIMENS. THERE ARE ADDITIONAL TRAILS ON THE PROPERTY. ONE KNOWN AS THE ADVENTURE WALK AND OTHER TRAILS INTO OTHER PARTS OF THE PROPERTY. TLNC PROVIDES A PLACE OF RESPITE FROM STRESS, A PLACE TO EXPERIENCE WONDER AND A PLACE TO LEARN IN A VERY DIFFICULT AND UNCERTAIN YEAR ABOUT AND CONNECTING WITH NATURE.
