Cooperative Purchasing - Offering a cooperative purchasing program through ValuePoint, members lead and participate on sourcing teams to address the needs of their States and deliver best value contracts for the benefit of the public. During 2020, the ValuePoint purchasing cooperative facilitated the execution of over 650 statewide and 1300 local participating addendums. In 2020, NASPO ValuePoint continued to support state and local public entities throughout the country in their efforts to meet the procurement-related demands in response to Covid-19; including providing resources for supplier vetting, assistance navigating the CARES Act and other Federal funding; as well as engaging with current ValuePoint suppliers to help ensure access to PPE, testing kits, and other high demand supplies and services. Shared supplier information to states to help combat counterfeit PPE. Helped Lead States administer over 400 contracts with sales in all 50 states and the District of Columbia. Provided \$244,094 to States to market their own in-state purchasing cooperatives. Provided States with no administrative fee contracts for public interest goods such as WIC Infant Formula and Child Safety Seats.

4b (Code:) (Expenses \$ 3,028,969 including grants of \$) (Revenue \$ 102,676)

Professional Development - NASPO offers a multi-faceted education platform for members and other state and local government procurement professionals. Procurement U provides training, publications, and certification exam support. To support states, NASPO also offers a professional development fund to support the professional growth of state procurement professionals. During 2020, NASPO provided \$1,221,512 in funding to 48 states and the District of Columbia. Procurement U offered virtual learning sessions at each of the NASPO conferences. This provided educational sessions to 652 attendees. Conducted an instructor led training free of charge for over 30 state procurement professional, Better RFPs Better Projects. Procurement U had 1,000 new users create accounts in the Learning Management System. Procurement U partnered with several nationally acclaimed universities to help develop curriculum around public procurement. As part of this initiative, NASPO offered 30 scholarships for an online public procurement course at an academic partner. To combat workforce shortages in states and help attract qualified candidates, NASPO administered an internship program for states to participate in. This program placed 6 students in virtual internships with states across the country. Procurement U provided prep courses to support professionals seeking to achieve their certification from the Universal Public Procurement Certification Council. CPPO/CPPB Exam Prep Course registrations increased by 15%. Participants achieved a 73% pass rate for the CPPB Exam and 88% for the CPPO exam. To encourage the education and development of future procurement professionals, the Procurement U Team provided \$5,000 scholarships to six university partners. These scholarship funds were distributed to full-time students at the universities to be utilized for tuition. In 2020, NASPO attended six academic partner career fairs, both in person and virtually. For over a year, Procurement U has worked hard to become an accredited procurement education provider through IACET, the premier standards-setting organization for continuing education and training. Procurement U submitted its final accreditation application to IACET in 2020. IACET conducted a virtual visit in October, and in November, they approved NASPO as an IACET Accredited Provider.

Conferences - Conferences are an integral part of the organization by allowing members to share best practices and learn new skills. NASPO provides our conferences at no cost to our members because of the importance of bringing together our members. With the COVID-19 pandemic, we transitioned our in-person conferences to a virtual environment to still allow our members to come together. Virtual also allowed us to open our conferences up to a wider audience within the state offices and allow for more attendees. Held our bi-annual NASPO REACH conference with 479 participants including 77% first time attendees. Achieved a 97% satisfaction rate with the virtual platform and a net promoter score of 70. Our 2020 NASPO Annual Conference was held as a hybrid event with 173 participants with 20% being first time attendees. Attendees reported 98% expectation met or exceeded with the conference and 96% satisfaction with the virtual platform. Attendees reported an 82 net promoter score.
