ADVOCACYAI JUSTICE'S LITIGATION PROGRAM JOINED A TEAM OF NATIONAL AND LOCAL CO-COUNSEL IN BRINGING A FEDERAL CLASS ACTION ON BEHALF OF ICE DETAINEES IN THE THREE DETENTION CENTERS IN SOUTH FLORIDA TO OBTAIN THE RELEASE OF THOSE INDIVIDUALS IN PARTICULAR DANGER FROM CONTRACTING COVID-19 AND TO IMPROVE THE DIRE CONDITIONS OF DETENTION FOR ALL DURING THE PANDEMIC. THE PROGRAM ALSO FILED TWO FEDERAL LAWSUITS ON BEHALF OF ONE CHILD AND ONE FAMILY WHO WERE SEPARATED AT THE BORDER IN 2017 DURING THE EARLY DAYS OF THE TRUMP ADMINISTRATION'S FAMILY SEPARATION POLICY.
