The main function of this program is to provide financial assistance to these families, these are, but are not limited to: efraying hospital expenses, medical consultations, medications, tests, surgeries, procedures, medical equipment, home health ices and fees for medical professionals. In addition, the mortgage or rent/house payment is paid, help with air transportation, food costs, household items(air conditioners, humifidiars, refrigerators, room sets, etc.), personal itema(diapers, creams, wet towels).
