Approximately 6,000 low income families received direct legal support using our legal support initiatives. More than 4,000 individuals participated of legal education workshops on housing and access to justice issues. Also, we launched a program that promoted legal education and support to people affected by the COVID-19 pandemic in regards to housing, labor law and access to information. In addition, advanced several access to information requests to monitor the use of federal funds amidst this new crisis. Promoted participation around disaster aid funds, promoting a narrative of equity and just recovery in administrative processes related to housing.
