The Center's objectives continue to be: (1) Provide support in times of need, including improved access to necessary services and resources; (2) Provide information to families to enhance age-appropriate development of their children, including social emotional competence; (3) Provide opportunities to increase individual and family social connections and decrease isolation and lack of social and family supports; (4) Increase knowledge of parenting and child development; and (5) Enhance parental resilience. The Center's achievements during the year included: 1. Operated two offices in two counties, providing an accessible family center and library with resources, information, and consultation with staff on a wide range of services and activities. Hours of operation: Monday - Thursday, 9am - 5pm.; 2. Provided 63 relevant trainings in group settings and 32 in individual settings; 3. Offered families 38 social activities for parents, children, siblings and extended family; 4. Provided 82 outreach activities to agencies serving children with disabilities/special needs and the general community.
