Rockwood FellowshipsRockwood convenes leaders within a given issue area or geographic region in order to catalyze more powerful and engaged learning communities and partnerships. Designed as a longer term, multi-retreat experience, each fellowship or partnership program identifies 12-24 influential leaders to engage in intensive training and receive tools in transformational leadership. Rockwood Fellowships & Partnerships were delivered in whole or in part in 2020 served a total of 279 leaders. These included: Building Power for Healthy Communities; Movement Leaders; Early Care, Learning and Health Leaders; Resource Leaders; Equity in Philanthropy; Leaders in Reproductive Health, Rights and Justice; Leadership Now Ohio; AOL for Oishei Foundation grantees; ANC for grantees of CZ1; a 2-day training for Women Leaders of Color grantees of Crossroads Fund; AOL for grantees of the JPB Foundation, and more.

Pubic TrainingsRockwood leads multi-day leadership development retreats for social change leaders from the nonprofit, philanthropic, labor and socially responsible business sectors. This work includes our flagship "Art of Leadership" (AOL) training as well as the newer "Art of Navigating Change" (ANC). In 2020, Rockwood offered a total of seven public trainings, in which 192 individuals participated. This included 3 in-person retreats and 4 virtual retreats.

YearlongsRockwood's Leading from the Inside Out Yearlong Program convenes senior executive leaders from across the United States.
