Environmental Education: CEC's newest program connects formal & informal educators to increase the quality & quantity of education specific and relevant to the greater Houston/Gulf Coast region. Many local educators, both formal and informal, have expressed an interest in teaching about Greater Houstons environment - both its challenges and its many resources - yet they often teach about other places for lack of local knowledge and materials. CEC's education programs provide resources to teach about climate, bayous, sea turtles, water and air quality, prairie chickens and prairies, climate change, and nature in our backyard. In 2019 Q3, CEC hired an environmental education specialist to manage this program. In 2020, the specialist coordinated numerous in-person professional development opportunities in 2020 working with dozens of educational partners, and then pivoted to provide virtual learning opportunities. In all, almost 1,800 educators attended in-person and virtual education events in 2020. Moreover, the education specialist coordinated several collaborative grant applications that resulted in over \$120,000 in grants for CEC and its partners. The grant-funded programs (and subsequent reimbursements) were largely deferred into future years due to COVID.

Green Films: CEC has grown its green films program from a one-night, sold out, on tour 2015 showing of the Wild & Scenic Film Festival on tour festival into the Houston Green Films and Festivals Program. The program comprises two annual festivals--the Wild & Scenic Film Festival on Tour and the Wild About Houston Green Film Festival--plus the Houston Green Film Series, which is a periodic screening of an environmental film followed by a panel discussion. CEC is increasingly able to use this program to highlight local environmental stories. Over 1,000 people attended CEC film events--in person and virtually--in 2020.

Outreach: CEC works to support and promote the work of its members, about 130 organizations that do environmental work in the Houston region. This includes speaking and/or tabling at their events, inviting them to speak at CEC events, and putting various groups in touch with each other. CEC participates as an advisor or stakeholder for initiatives including governance of the Coalition for Environment, Equity and Resilience (ceerhouston.org); the Houston Climathon; Harris Countys Environmental Justice and Resiliency Do-Tank; the City of Houstons Climate Action Plan and Group. CEC also responds to requests from various audiences, providing referrals and information on topics such as: Service learning opportunities in Houston related to the environment and justice from multiple college groups around the country Resources to stop a concrete batch plant causing pollution in a residential neighborhood How to recycle VHS tapes Protection of urban trees Student projects related to environmental careers, the landscape of environmental action in Houston, and the impact of flooding on the environment in Houston How to remove bats from a commercial building Proposal by the US Army Corps of Engineers to channelize of Buffalo Bayou Finding a recording of a candidate forum hosted by one of CECs member organizations To whom an incident of large smoke rings should be reported for investigation Concerns about the redevelopment by a Tax Increment Reinvestment Zone of one of Houstons oldest parks
