The date of the IRS letter advising me of the requirement for electronic filing is October 28, 2021, however the postmark shows that it was not mailed until November 17, 2021. The IRS packet probably did not arrive in our PO Box until the 19th or 20th of November. Just prior to that date my mentally ill son was picked up by the local sheriff, because he was a danger to himself and others in the community, and involuntarily confined in mental health hospital. I spent my time dealing with his healthcare needs and arranging for his care once he was discharged from the hospital. As a result, I did not check the charity's PO Box until November 28th. It has taken me a few days to find an electronic filing service, learn how to use it and complete the electronic return.
