We also received CARES Act funding from San Bernardino and Riverside County to provide capacity building and PPP and EIDL technical assistance to nonprofits in the region in response to Covid-19. IECC pivoted from traditional capacity building efforts to providing vital technical assistance for virtual and digital needs due to pandemic restrictions. The grants total was approximately \$70,000.
