To be the primary location in our community for assistance, compassionately providing resources with respect and dignity to those in need. Volunteers provided 9,245 hours of service for approx. \$100,000 of value to the community efforts of Servants Heart.

Household Needs consist of BillPay and NonFood Pantry services. BillPay assistance helps struggling families pay rent, mortgage, and utilities. This assistance keeps families from experiencing homelessness and remain housed. Servants Heart (SH) assisted with approximately \$183,035 of such direct payments for the aforementioned costs. The NonFood Pantry provides up to 25 different categories of needs for personal hygiene, cleanliness, and healthy living for items that cannot be purchased by food stamps.

Food deficiencies were met through our Emergency Food Pantry, Loaves & Fishes, and Turkey Tuesday. The Emergency Food Pantry provides food whenever food is needed. Loaves & Fishes is on Thursdays only, and Turkey Tuesday is for Thanksgiving only. In addition to non perishable food items, each family may receive a gift card to purchase meat, and another \$15 for special ingredients to complete a meal. The amount of food per family is based upon the number of people living in each household together. In 2020, 2,317 people were provided assistance from the Emergency Food Pantry.

Back to School Program for Children. School aged children are provided a fully stocked bookbag from PreK through 8th Grade based upon the grade level list provided for each grade. The bookbags can be picked up by parents prior to school beginning to enable students to be prepared for school on Day 1. High School and College students are also served by this program on an individual needs basis. During 2020, SH served 413 children, students from 13 - college age, providing approximately \$37,355 in total school assistance.
