In Beloved Community's third year we supported 22 organizations with ongoing facilitations, trained 135 organizational leaders and 645 employees in diversity, equity, and inclusion practices. We celebrated the following impact and milestones: 1) Equity Audit Tool Suite: In FY20 Beloved Community launched a 3-year research study on the Equity Audit use in diverse-by-design schools. In addition to the research study, the Equity Audit reached: 294 organizational inquiries, 65 completed equity audits from organizations in 19 states, respondent represented all three target organizational types: nonprofits/colleges/universities (44), k-12 schools (16), and for profit businesses(5), respondents represented 9 sectors. 2) Capacity-building services: In FY20 Beloved Community provided equity training for 135 organizational leaders and 645 employees via 3 programs: deep dive engagements including workshop facilitation, leadership coaching, equity work plan development, and train-the-trainer supports for 9 nonprofit agencies, equity assessments for 3 philanthropic agencies on their grantees' diversity, equity, and inclusion capacity for 84 nonprofit agencies, 14 1-day workshops, and 27 conference presentations on our model. 3) Communities of practice: Equity in Schools Cohort in Indianapolis supporting 6 school founders in the development of their equity plans, Equity at Work Cohort in Memphis supporting 8 nonprofit teams in the development of their equity work plans, engage DEI cohort supporting 9 nonprofit teams in their Equity Audit assessment, and UnifED Fellows supporting 4 school teams in their Equity Audit assessment.
