DURING THE SHORT YEAR PERIOD COVERED BY THIS RETURN, ENCOMPASSING JAN 1,2020 - JUNE 30, 2020, THE COVID-19 PANDEMIC FORCED US TO SWITCH OUR PROGRAMS TO A VIRTUAL PLATFORM. EPIC PIVOTED IMMEDIATELY AND CONTINUED TO OFFER CLASSES 6 DAYS A WEEK, SOMETIMES TWICE A DAY FOR PLAYERS TO ATTEND FOR FREE. OVERALL, WE WERE ABLE TO PROVIDE FREE CLASSES TO OVER 81 ARTISTS WITH DEVELOPMENTAL DISABILITES. WITH OUR FREE CLASSES, WE HOPE TO PROVIDE THE TRAINING AND SUPPORT NEEDED FOR OUR PLAYERS TO PURSUE A MEANINGFUL CAREER IN THE ARTS AND TO EXPOSE STUDENTS WITH DISABILITIES TO A PATHWAY TO ACCESSIBLE ARTS AND CREATIVE CONFIDENCE. ADVOCACY: THROUGHOUT THE PANDEMIC AND THE EARLY PART OF 2020, EPIC PRESENTED AT NATIONAL CONFERENCES AROUND THE COUNTRY, SPECIFICALLY THE "UNCONFERENCE" WITH THE UNITED STATES DEPARTMENT OF EDUCATION, TO PROMOTE INCLUSIVE THEATER ARTS EDUCATION PRACTICES AND ACT AS AN ELEVATED PLATFORM FOR DISABILITY ARTS.
