We published 16 books in 2020 for both adult and young readers, the majority of which were in translation. By the end of 2020, we had 101 titles in print and/or in eBook which forward our mission of expanding readers' understanding of the world. Books are sold across the country and internationally at digital retailers, via our website, and by our distributor, Publishers Group West. In addition to our publishing program we run the Restless Books Prize for New Immigrant Writing, which awards \$10,000 and publication with Restless Books to a writer who has produced a work that addresses the effects of global migration on identity.
