THE SERVICES OF THE BREDEL VETERINARY CLINIC ARE DESIGNED TO IMPROVE THE LIVES OF COMPANION ANIMALS AND REINFORCE THE HUMAN-ANIMAL CONNECTION. SERVICES INCLUDE: CONSULTATIONS, EXAMINATIONS, SURGERIES, VACCINATIONS, SPAY AND NEUTER SURGERIES, DENTAL PROCEDURES, DIGITAL RADIOLOGY, AND LABORATORY TESTS. THE BREDEL CLINIC ALSO RECEIVES GRANTS THAT COVER LOW COST AND NO COST SURGERIES FOR LOW INCOME RESIDENCE RESIDING IN MARYLAND, WEST VIRGINIA, AND PENNSYLVANIA.

THE HOTEL OFFERS MULTIPLE SPACIOUS DOG DENS AND CAT CONDOS, 24 HOUR SECURITY, LOTS OF EXERCISE, AND TONS OF HUGS AND LOVE TO ENSURE ALL OF ITS GUESTS ARE SAFE AND HAPPY DURING THEIR STAY.

THE ADOPTION MANAGER EVALUATES ALL POTENTIAL ADOPTERS TO ENSURE THE PET GOES TO THE BEST SUITED HOME. ALTHOUGH THE ADOPTION WING FINDS HOME FOR MANY ANIMALS, HART STILL CONTINUES TO DO TRANSPORTS TO RESCUE GROUPS IN SURROUNDING METROPOLITAN AREAS, WHERE SOME OF THE ANIMALS HAVE A GREATER CHANCE OF BEING ADOPTED.

PICK OF THE LITTER 20,041 HART FOR ANIMALS OPERATES ITS THRIFT SHOP AT MCHENRY PLAZA AS A WAY OF RAISING FUNDS FOR ITS VARIOUS ANIMAL WELFARE PROGRAMS. OPENED IN APRIL 2013, THE STORE HAS BECOME A STOPPING PLACE FOR RESIDENTS AND VISITORS, WITH ITS SELECTION OF HOUSEWARES, LAWN AND GARDEN ITEMS, BABY FURNITURE, CHILDREN'S TOYS, SMALL APPLIANCES, PET TOYS AND ACCESSORIES, AND OTHER HOUSEHOLD ITEMS HART SHOPPE 7,663 THE HART SHOPPE IS A SMALL RETAIL CORNER LOCATED IN THE MAIN HART FOR ANIMALS LOBBY.
