ONE THE NGP SIDE, WE REMAINED FOCUSED ON VOTER REGISTRATION AND EDUCATION DURING A PIVOTAL AND DEEPLY DIVIDED ELECTION YEAR. WE INTRODUCED ORGANIZING TOOLS, AND WORKED WITH COMMUNITY MEMBERS TO IDENTIFY THEIR REASONS FOR VOTING INCREASES THE CIVIC PARTICIPATION OF LOW-PROPENSITY VOTERS OF COLOR AND BUILDS POWER FOR THE LONG TERM. WE REMAINED RELENTLESS YET ADAPTABLE IN THE FACE OF MANIFOLD CHALLENGES, INCLUDING CONTINUED VOTER SUPPRESSION TACTICS AND THE COVID-19 PANDEMIC. IN THE SPRING, WE WERE FORCED TO PIVOT OUR IN-PERSON DEEP CANVASSING STRATEGIES AND IMMEDIATELY SHIFTED OUR ENGAGEMENT TO VIRTUAL PLATFORMS. USING PHONES, TEXTS, SOCIAL MEDIA, ZOOM, AND INNOVATIVE ONLINE PLATFORMS WE WERE ABLE TO SAFELY AND EFFECTIVELY MEET GEORGIANS, ESPECIALLY YOUNG PEOPLE, WHERE THEY ARE.
