CPI also worked to place qualified staffers in public policy positions in government and other nonprofit organizations. CPI hosted policy meetings and informal gatherings and provided space for government leaders and staffers, nonprofit leaders and staffers, and advocates to meet and debate policy. Finally, CPI educated the public by having staffers comment on policy and procedural issues through giving radio and television interviews and publishing op-eds.
