THESE SPACES ARE DESIGNED AND MANAGED BY LOCAL RESIDENTS WITH SUPPORT FROM PARTNERS IN LOCAL GOVERNMENTS, AS WELL AS THE PRIVATE AND NONPROFIT SECTORS. LOCATED IN COMMUNITIES OF NEED THROUGHOUT THE ISLAND, THE HUBS MEET THE IMMEDIATE COMMUNITY OF FOOD ASSISTANCE, COMMUNITY AND FAMILY RESISTANCE, AND CONNECTIVITY ENHANCEMENT. TO STRENGTHEN RELATIONSHIPS, BUILD SOCIAL CAPITAL AND FOSTER WELLNESS, COOPERATION, AND TRUST, THE SPECIFIC PROGRAMS OFFERED BY EACH HUB ARE DRIVEN, PRIORITIZED, AND RUN BY COMMUNITY MEMBERS. DURING 2020, THE ORGANIZATION MADE AND DELIVERED 2,000 MASKS, PREPARED AND DISTRIBUTED 5,000 KUPUNA PACKS OF FOOD AND LIVING NECESSITIES FOR THE ELDERLY, 8,700 KEIKI PACKS OF LEARNING SUPPLIES, 2,096 FOOD BAGS ABLE TO PRODUCE 38,428 MEALS, AND DELIVERED 3,800 HOT MEALS TO HOMES ACROSS THE ISLAND.

THE YOUTH IN THIS PROGRAM COME FROM TROUBLED FAMILIES AND DISADVANTAGED BACKGROUNDS, AND THEY USUALLY LACK INTERPERSONAL AND PROFESSIONAL SKILLS THAT ARE CRUCIAL TO SUCCEED IN ADULTHOOD. BY ATTENDING HAWAII RISE FOUNDATION'S WORKSHOPS, WE HAVE ASSISTED WITH DEVELOPING THEIR PROFESSIONAL AND PRACTICAL LIFE SKILLS. THESE SKILLS INCLUDE, BUT ARE NOT LIMITED TO, HEALTHY RELATIONSHIP IDENTIFICATION AND DEVELOPMENT, RESUME BUILDING, FINANCIAL WELLNESS, INTERVIEW PRACTICE AND PREPARATION, CULTURAL IDENTITY AWARENESS, AND MANY MORE. THE YOUTH IN THE ACADEMY ARE ABLE TO BUILD RELATIONSHIPS WITH DIFFERENT MEMBERS OF THE COMMUNITY WITH WHOM THEY CAN TRUST. THE CADETS HAVE ALSO BEEN ABLE TO LISTEN TO HAWAII TV PERSONALITIES PASHYN AND WENDY SANTOS, WHO PUT ON A MOTIVATIONAL GUEST SPEAKER WORKSHOP, INTERACTING WITH THE YOUTH AND PRESENTING ON "HONORING OUR PAST, NAVIGATING OUR PRESENT, AND EMPOWERING OUR FUTURE". THE YOUTH WERE ABLE TO HONOR THEIR PAST, PRESENT, AND FUTURE IDENTITIES AND CONNECT WITH THEIR INNER SELVES.

RISE-UP DOMESTIC VIOLENCE HOUSING PROGRAM. HAWAII RISE FOUNDATION'S DOMESTIC VIOLENCE PROGRAM IN PARTNERSHIP WITH NA KAHUA HALE O ULUWINI/COUNTY PROGRAM HAS BEEN ABLE TO PROVIDE TRANSITIONAL HOUSING AND CASE MANAGEMENT ALONG WITH RENTAL ASSISTANCE AND PERMANENT HOUSING FOR OVER 15 DOMESTIC VIOLENCE VICTIMS IN THE FIRST YEAR OF FUNDING ON HAWAII ISLAND. THESE FAMILIES HAVE BEEN PROVIDED WITH CLEAN, SAFE HOUSING IN ORDER TO STABILIZE AND MOVE FORWARD WITH THEIR LIVES. THEY ARE GIVEN SUPPORT TO GET THROUGH THE TRAUMA EXPERIENCED WHILE BEING ABUSED, AND OUR PROGRAM GIVES THEM AN OPPORTUNITY TO HAVE A SAFE PLACE TO LIVE WHILE THEY HEAL. OUR RAPID REHOUSING RENTAL ASSISTANCE CAN PROVIDE UP TO ONE YEAR OF RENTAL PAYMENTS ALONG WITH UTILITY DEPOSITS AND SUPPORTIVE SERVICES INCLUDING COUNSELING, TO HELP GET THEM BACK ON THEIR FEET. WE WORK CLOSELY WITH DIRECT SERVICE PROVIDERS WHO SERVE FAMILIES TO HELP IDENTIFY THOSE WHO NEED HELP.
